

**BLUEWATER SCUBA**  
**PARTY/POOL RENTAL AGREEMENT CONTRACT**

BLUEWATER SCUBA, 320 Mallory Station Road, Franklin, TN. 37067, shall be available for use by the public on a reservation basis subject to the conditions outlined below. The purpose of these guidelines is to establish standard procedures for administering the policy and to ensure fairness in the letting of the facility.

**The applicant granted the reservation agrees to read and abide by the following:  
PLEASE READ AND INITIAL EACH STATEMENT TO INDICATE AGREEMENT. YOU MAY FAX THIS FORM TO BLUEWATER AT 615-771-0016, SCAN AND E-MAIL PRIOR TO PARTY, OR DELIVER IT TO STORE.**

\_\_\_\_\_ 1. User agrees to indemnify and hold harmless Bluewater Scuba, its agents and employees from and against any claims for damages or injuries to persons or property arising out of or related or incident to any use of Bluewater Scuba and its premises, services, equipment or facilities by User or User's guests or persons associated with User. Bluewater Scuba assumes no responsibility for any person or property placed in or about the Bluewater Scuba facility.

\_\_\_\_\_ 2. User agrees to assume all responsibility for any damages done to the premises or facility or equipment as a result of the usage by them, their guests, or persons associated with User. User shall be responsible for the cost for repairs and/or replacement based on Bluewater Scuba's assessment of damages as determined by the sole discretion of Bluewater Scuba.

\_\_\_\_\_ 3. **Persons requesting a reservation must fill out a "Party Contract and Guest List" form. The completed application must be submitted to Bluewater Scuba with the party payment. Form may be faxed (615-771-0016) with credit card information.** All reservations must be confirmed and approved by an employee of Bluewater Scuba. Any balance of payment will be payable on the day of the party prior to the arrival of any guests. An additional charge will be charged over the initial 15 participants. Total participation limited to 20 guests in the pool at any one time without prior approval by Bluewater Scuba. No oral agreements for use of Bluewater Scuba shall be valid.

\_\_\_\_\_ 4. **Party participants and guests: Please use side (west) parking lot.**

\_\_\_\_\_ 5. **Persons under 18 are not allowed in the men's and women's locker rooms, unless accompanied by a parent or guardian.** Persons under 18 may utilize the restrooms marked "handicap" across from the party room.

\_\_\_\_\_ 6. **Bluewater Scuba is not responsible for loss or damage of valuables.**

\_\_\_\_\_ 7. Children 4 and under required a one-on-one parent/adult companion in the water at all times. Parties for children who are 5 & 6 require at least 3 parent/adults on the pool deck at all times in addition to the lifeguard provided by Bluewater Scuba.

\_\_\_\_\_ 8. **Party host will furnish names, addresses and emergency phone numbers of all party participants to Bluewater Scuba on the day of the party prior to or upon arrival of each guest, utilizing the "Party Contract and Guest List" form.**

**PARTY/POOL RENTAL AGREEMENT CONTRACT (con't)**

\_\_\_\_\_ 9. **PARTY ROOM RENTAL IS LIMITED TO PRE-POOL ACTIVITIES. USER AGREES TO CLEAN PARTY ROOM DURING POOL PART OF PARTY. GUESTS ARE NOT TO RE-ENTER PARTY ROOM AFTER CONCLUSION OF PARTY.** User agrees to leave the premises in as good or better condition than which existed prior to their usage. All trash must be disposed of properly. All decorations must be promptly removed. A \$50 charge shall be due and payable by User if the premises are not properly cleaned based on a post party inspection by a Bluewater Scuba representative.

\_\_\_\_\_ 10. User is responsible for the set-up of the party room. Set-up time is approximately 30 minutes prior to the party. The User should not attempt to gain access to the facility prior to this time.

\_\_\_\_\_ 11. Bluewater Scuba shall not permit any alcoholic beverages, drugs, or other intoxicants to be served, displayed, or consumed on its premises or in the areas surrounding the facility at any time. A violation of this policy shall be grounds for immediate termination of such party and User shall not be entitled to a refund of any portion of amounts paid to Bluewater Scuba. **SMOKING IS NOT PERMITTED ANYWHERE ON THE PREMISES.**

\_\_\_\_\_ 12. Refreshments may only be served in pre-designated areas. Absolutely no refreshments or food in the pool area.

\_\_\_\_\_ 13. No glass containers will be allowed anywhere in the Bluewater Scuba facility.

\_\_\_\_\_ 14. All pool safety rules must be followed by User and guests, including without limitation:

- a. No running in pool area.
  - b. No diving.
  - c. No pushing, shoving, sitting on shoulders, or holding guests under the water.
  - d. No food or gum to be consumed while in the pool.
  - e. Lifeguard will be final authority in enforcing safe behavior.
- Lifeguard /Scuba Instructor is there for the safety of User and all guests.

\_\_\_\_\_ 15. **Cancellations are requested at least two weeks prior to the party date. Cancellations made within seven days of the event will result in \$50 cancellation fee.**

\_\_\_\_\_ 17. Bluewater Scuba reserves the right to cancel this reservation at any time if the building, pool or staff conditions would create, in Bluewater Scuba's opinion, an unsafe or unsuitable environment for participants.

**NOTE: All of the above rules and regulations are subject to change at any time.**
